This annual report gives you a snapshot of the activities and accomplishments of the American Red Cross of Allen, Auglaize and Hardin counties. FY09 presented many challenges ranging from the substantial construction project on the North end of the Chapter House to the record year for single-family fires.

Throughout it all, your Red Cross provided vital services and programs without missing a beat.

We continue to work with our Regional Chapter, the Greater Toledo Area Chapter, to provide valuable Red Cross services. During FY09 we collaborated with the Regional Chapter for the back-office functions resulting in cost-savings and the streamlining of all fiscal transactions.

The Blood Services program of the Allen County Chapter experienced a very positive year and the chapter was recognized with a "Partnership Award" from the Indiana-Ohio Blood Region. All of the Red Cross services provided in our three-county area are the result of dedicated staff members and volunteers.

We extend our appreciation to our volunteers, blood donors, financial donors, employees and business partners for making FY 09 an excellent year for the American Red Cross of Allen, Auglaize, and Hardin counties and the communities we serve.

## The Red Cross in Your Community

- +** 229 people received Red Cross Assistance after their homes were damaged or destroyed due to a disaster in Allen County, 18 people were helped in Auglaize County and 57 people received assistance in Hardin County.
- +** 107 emergency messages were relayed to service members of local military families.
- +** 4,746 people attended disaster education presentations or demonstrations
- +** 4,670 people enrolled in Red Cross Health & Safety classes in Allen County. 496 people in Hardin County were enrolled, as well as, 386 in Auglaize County.
- +** 94 blood drives were held collecting 4,305 units of blood in Allen County. Auglaize County held 56 blood drives and collected 2,822 units of blood. Hardin County held 47 blood drives and collected 1,740 units of blood.
- +** Over 245 volunteers gave of their time last year and provided over 6,280 hours to the mission of the American Red Cross. Thank you volunteers, we could not do it without you!

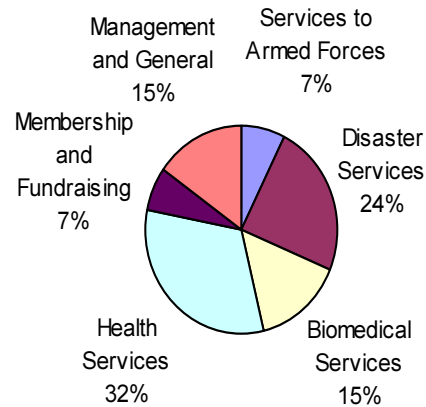
